Presented for consideration to the august body by the Barangay Chairman Hon. Roberto P. Monterola during its regular session is the above titled resolution.

WHEREAS; the said irrigation boxes in Lower San Vicente of this barangay was damaged by past and recent typhoons, which may greatly affect the constant flow of water supply to predominantly large rice field which is the major crop and source of income in the community,

WHEREAS; the Sangguniang Barangay of Kilim has no sufficient fund to finance for the rehabilitation of said irrigation boxes, and so we are strongly believing on the strong support wholeheartedly cooperation of the Province Government Office of Agriculture thru the City Agriculture Office Agriculturist Elena P. Siddiqui,
