## WELCOME

We would like to welcome you to Manhattan, Illinois. We look forward to helping you get familiar with our services and all the Village has to offer.

The Village was incorporated in 1886 and became a home-rule municipality by way of a referendum held on November 5, 1996. The Village serves an area of approximately six square miles located in Manhattan Township in Will County, Illinois, approximately 9 miles southeast of the City of Joliet. Manhattan is in an enviable position of nearby access to four major interstate highways, 7 miles from I-80, 10 miles from I-355, 11 miles from I-57, and 12 miles from I-55, with Metra commuter rail service to downtown Chicago. According to a 2010 census, the Village has a population of 7,051. Since the early 2000's, the Village experienced consistent growth and continues to gain additional permits through lowered development and impact fees.

The Village operates under the Village President-Trustee form of government. The Village President and six trustees are elected at large. The Village Clerk is also elected at large. The Village President, with the consent of the Village Board, appoints the Village Treasurer and Village Administrator.

**WATER/SEWER/GARBAGE SERVICE** - New residents are required to complete an application for service prior to moving in. Billing statements are mailed monthly and due the last day of the month. For your convenience, payments can be:

- In person at the Village Hall, Monday Friday, 8:30am 4:30pm
- 24hour drop box at Village Hall
- In person at any First Bank of Manhattan location
- Online at our website
- Auto Pay payments are deducted directly from your bank account on the last business day of each month

**TRANSFER STAMPS** – The Village of Manhattan does not require transfer stamps.

GARBAGE/RECYCLE – Garbage cans are provided by Waste Management. Please telephone the Village Hall for the totes if they are not already at the residence. The totes are property of Waste Management, when you move the totes must remain at the residence. Pickup day is Monday, please have your totes out by 6 am, but not before midnight on Saturday. Waste Management observes the following holidays: New Year's Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving and Christmas. When pickup falls on one of the holidays, garbage will be picked up the following weekday (Tuesday). One large household item, such as discarded furniture, mattresses, chairs, etc. will be collected on the regular pickup day. Additional oversized items may require a special pickup.

**YARD WASTE** – Collection is on Mondays from April 1<sup>st</sup> - November 30<sup>th</sup>. Yard waste must be placed in either a kraft-type paper bag, in a standard 32-gallon refuse container clearly marked with a "Yard Waste Only" sticker, or in a rented WM yard waste tote. Stickers are free and available at the Village Hall. Tree branches, bushes and limbs should be cut into 4' lengths and bundled with string or twine, and each bundle must weigh less than 50 lbs. Christmas trees will be collected after the holidays.

**AT YOUR DOOR SERVICE** - A special collection to dispose of electronics, household hazardous waste and other items picked up directly from your home. **LAWN WATERING** – Watering during the months of June, July and August is limited to even numbered addresses on even numbered days and odd numbered addresses on odd numbered days during the hours of 7 am to 10 am and 7 pm to 10 pm each day. There are no special exceptions for new sod. All in ground sprinkler systems must have a RPZ backflow prevention device installed.

**IN-GROUND SPRINKLER SYSTEM** - RPZ backflow prevention device must be installed and must be inspected on a yearly basis and results sent to the Village by July 1. The backflow device annual inspection is required by the State of Illinois.

**VEHICLE STICKERS** – The Village of Manhattan does not require vehicle stickers, but lifetime stickers can be purchased at Village Hall for \$1.

**DOG TAGS** – Dog tags are not required in the Village of Manhattan.

**PARKWAY TREES** - Residents are permitted to plant trees within the parkway (generally the area between the sidewalk and the street). A street planting application is required prior to planting. Any tree placed in the parkway must be on the approved street tree list.

**NO PARKING** - please take note that there is NO PARKING on the street when 2" of snow or 1" on ice. Lawn parking is also not allowed. Violators will be ticketed. Such rules are necessary so that emergency vehicles and snow removal vehicles can get through without obstruction.

**FIREWORKS** - fireworks are not prohibited in the State of Illinois.

**OPEN BURNING** – is prohibited of the following (including, but not limited to): leaves, grass, brush, trimmings from trees/bushes, garbage on any property, public or private, within the Village. Campfires are allowed but must be contained.

**WEEDS/TALL GRASS** – The Village has an ordinance against allowing weeds, grass or plants, other than trees, bushes, flowers or other ornamental plants to grow to a height exceeding 8 inches in the Village.

**SNOW REMOVAL** – Village ordinance (Ord. 611, 1-17-1995) No snow or slush removed from private property by way of shoveling, plowing or blowing shall be deposited upon any village sidewalk or the paved section of any public road, street or highway within the village. This is enforceable by the Manhattan Police with a fine of \$75.00.

**GOLF CART REGISTRATION** – All Golf Carts are required to be inspected and registered with the Manhattan Police Department. The cost of golf cart inspection/registration is \$50.00 annually. Golf Carts can only be operated on Village of Manhattan streets. A properly registered and inspected golf cart is considered a motor vehicle and all applicable state laws and local ordinances apply to its use on the Village streets.

Permit applications and guidelines are available on our website. When applying for permits, be sure to review all information needed to apply for the permit. A Plat of Survey is needed for most permits and copies are not kept at the Village. Also, your subdivision may require review and approval by your HOA. **CONTRACTOR REGISTRATION** - All general and sub-contractors engaging in business in the Village must be registered. Applications are available on our website or at the Village Hall.

**SPECIAL EVENTS** - If you are planning an outdoor event, such as a block party or parade, you must fill out a Special Event Permit Application. This application must be submitted at Village Hall at least two weeks prior to the event.

When you hear the sirens and are unsure of what they imply, please go indoors, turn your radio to one of the Emergency Broadcast Stations and listen for essential emergency information. DO NOT call local fire or police agencies to ask why the sirens are sounding. If it is an emergency, they are busy getting equipment and manpower to the scene.
