

# The Nottinghamshire County Council (Askham Road and High Street, East Markham) (Prohibition of Waiting) Traffic Regulation Order 2021 (1244)

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council **HAS MADE** an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at East Markham in the District of Newark and Sherwood: -

1. Vehicles will be prohibited from Waiting at any time along the following lengths of road: -

# ASKHAM ROAD, EAST MARKHAM (the east side)

- From its junction with the A57 East Markham By-Pass in a southerly direction for 43 metres.
- From its junction with High Street in a northerly direction for 12 metres.

## ASKHAM ROAD, EAST MARKHAM (the west side)

- From its junction with the A57 East Markham By-Pass in a southerly direction for 45 metres.
- From its junction with High Street in a northerly direction for 10 metres.

# **HIGH STREET, EAST MARKHAM** (the north side)

- From a point 10 metres north-west of its junction with Askham Road in a south-easterly direction to a point 10 metres south-east of that junction
- 2. Vehicles will be prohibited from **Waiting on Monday to Friday between 8am and 4.30pm** along the following: -

## ASKHAM ROAD, EAST MARKHAM (the east side)

- From a point 43 metres south of its junction with the A57 East Markham By-Pass in a southerly direction for 28 metres.
- From a point 97 metres south of its junction with the A57 East Markham By-Pass in a southerly direction for 17 metres.
- From a point 102 metres north of its junction with High Street in a southerly direction for 38 metres.
- From a point 44 metres north of its junction with High Street in a southerly direction for 32 metres.
