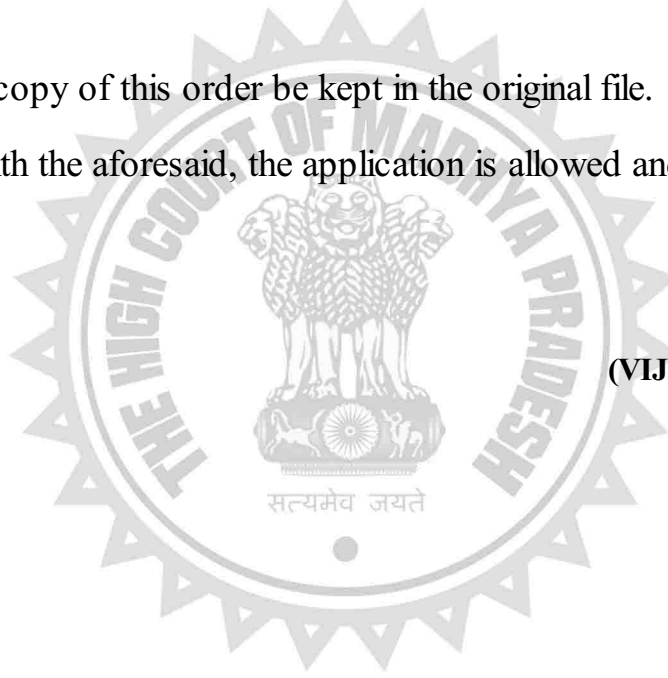
For the reasons stated in the application, the present application is allowed.
