SHOW CAUSE NOTICE UNDER SECTION 7(b) READ WITH SECTION 5(1)(a) OF THE PUNJAB EMPLOYEES EFFICIENCY DISCIPLINE AND ACCOUNTABILITY ACT, 2006.

WHEREAS, I, Special Secretary, Primary & Secondary Healthcare Department / Competent Authority, under the Punjab Employees Efficiency, Discipline & Accountability Act 2006, in due consideration of the facts of the case am of the view that there are sufficient grounds to proceed against you on the charge, which constitutes "misconduct" as defined under Section 2 of the Act ibid:-

"After expiry of EOL you were supposed to join this department on 01.06.2020 but you submitted joining report in this department on 10.02.2021. Afterwards, you were posted at RHC, Sarai Sidhu, Kabirwala on 19.02.2021 but you did not join your duty till date. As such you remained willfully absent from duty w.e.f 01.06.2020 to-date"

- 2. AND WHEREAS, the undersigned is of the opinion that it is not necessary to hold an enquiry into the matter, in view of the provisions contained in Section 5(1)(b) of the Act ibid. It is, therefore, proposed to proceed against you under Section 7(b) read 0with Section 5(1)(a) of the Punjab Employees Efficiency, Discipline and Accountability Act, 2006.
- 3. NOW, THEREFORE, you are hereby called upon to show cause in writing within seven (07) days of the receipt of this notice as to why one or more penalties as prescribed in Section 4 of the Punjab Employees Efficiency, Discipline and Accountability Act, 2006 may not be imposed upon you.

- 4. Your reply to this show cause notice should reach the undersigned within the said period, failing which it shall be presumed that you have no defense to offer and have admitted the charge.
- 5. In case you desire to consult any record on which the aforesaid charge is based or is relevant to the aforesaid charge, you may do so through prior arrangement with the Secretary P&SHD / Competent Authority within seven (07) days from receipt of this notice.
- 6. If your reply is not received within the stipulated period, ex-parte proceedings shall be taken against you as provided under Section 7(c) of the Act ibid.
